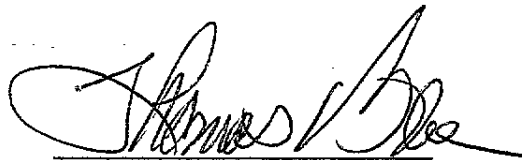
RESOLVED, that Article I of the Articles of Incorporation of the Corporation be deleted in its entirety and amended to read as follows:

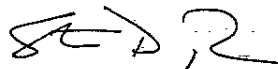
