The undersigned subscriber(s) to these Articles of Incorporation are natural person competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

**ARTICLE I**

**NAME**

The name of this Corporation shall be WHIDDON INDUSTRIAL COATINGS, INC. The Corporation's principal address and the registered office address are the same.

**ARTICLE II**

**DURATION**

The Corporation shall have a perpetual existence.

**ARTICLE III**

**PURPOSE**

The purpose of this Corporation is to engage in any activities or business permitted under the laws of the United States and Florida.

**ARTICLE IV**

**CAPITAL STOCK**

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 5,000 shares of common stock having a par value of \$1.00 per share.
