AMENDED AND RESTATED ARTICLES OF INCORPORATION

OF

TACKLEMANIA.COM, INC.

Pursuant to Section 607.1007 of the Florida Business Corporation Act, the undersigned officer of **TackleMania.Com**, **Inc.**, under the Florida Business Corporation Act, adopts the following Amended and Restated Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation (the "Corporation") is TackleMania.Com, Inc..

ARTICLE II

ADDRESS
