ARTICLES OF INCORPORATION OF

RS LEASING, INC.

The undersigned, being an individual, does hereby act as incorporator for the purpose of organizing a corporation for profit pursuant to the provisions of the Rhode Island Business Corporation Act, and therefore, adopts the following Articles of Incorporation for such corporation.

ARTICLE I NAME

The corporate name for the corporation (hereinafter the "corporation") is:

RS LEASING, INC.

ARTICLE II EXISTENCE AND DURATION

The period of duration of this corporation is perpetual.

ARTICLE III PURPOSES AND POWERS

The purpose for which this corporation is organized is to engage in all lawful business for which corporations may be incorporated pursuant to the Florida Business Corporation Act. In furtherance of such lawful purposes, the corporation shall have and may exercise all rights, powers and privileges now or hereafter exerciseable by corporations organized under the laws of the State of Florida.
