The undersigned, acting as incorporator, of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I. - NAME

The name of this corporation shall be L D CARPENTRY, INC..

ARTICLE II. - PRINCIPAL OFFICE
