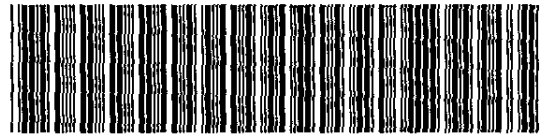

Pursuant to Section 607.1006, Florida Statutes, AUTOQUOTES (FLORIDA), INC., a Florida corporation having its principal office in Jacksonville, Florida (hereinafter called the "Corporation"), hereby certifies as follows:

FIRST: The name of the Corporation is AUTOQUOTES (FLORIDA), INC., a Florida corporation.

SECOND: The shareholders of the Corporation, acting pursuant to Sections 607.0704, 607.0706, 607.1003 and 607.1006, Florida Statutes, have executed a written consent dated as of March 21, 2006 authorizing amendment of the Articles of Incorporation of the Corporation in the manner provided by the Florida Business Corporation Act, by deleting existing Article III in its entirety and inserting in lieu thereof the following:

ARTICLE III - SHARES

This Corporation is authorized to issue two hundred (200) shares of common stock, all of which shall be of the par value of One Dollar (\$1.00) per share.

THIRD: The foregoing amendment was adopted as of March 21, 2006.


FOURTH: The holders of all common shares of the Corporation were entitled to vote on the foregoing amendment to the Articles of Incorporation of the Corporation. The number of votes


cast in favor of the foregoing amendment to the Articles of Incorporation was one hundred percent (100%) of the common shares eligible to vote. The number of votes cast for the foregoing amendment to the Articles of Incorporation was sufficient for approval.

FIFTH: The foregoing amendment to the Articles of Incorporation of the Corporation shall become effective upon the filing of these Articles of Amendment with the Secretary of State of the State of Florida.
