**ARTICLE I
NAME & PLACE OF BUSINESS**

The name of the Corporation is JUSTINGEMS INC. The principal place of business and mailing address of the corporation shall be as follows: 2451 Brickell Avenue, #9M, Miami, Florida 33129.

TERM OF CORPORATE EXISTENCE**
