

The name of this corporation is ACE METAL POLISHING CO., INC.

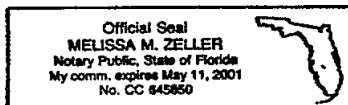
