ARTICLES OF INCORPORATION

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I ~ NAME

The name of the corporation shall be JET SHED, INC.

ARTICLE II ~ PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation shall be 465 West Merritt Island Causeway, Merritt Island, Florida 32952.

ARTICLE III ~ CAPITALIZATION

The number of shares of stock that this corporation is authorized to have outstanding at any one time is one thousand, in a single class, without par value.

ARTICLE IV ~ CORPORATE DURATION

The corporation shall commence existence on June 5, 1998 and shall have perpetual existence.

ARTICLE V ~ PURPOSES

The general purposes for which the corporation is organized are:

1. To engage in the business of service and sales of maritime watercraft.
2. To transact any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act.
3. To do such other things as are incidental to the above or necessary or desirable in order to accomplish the above.

ARTICLE VI ~ INCORPORATOR

ARTICLE VII ~ DIRECTOR
