Section 1.1. Name. The name of the corporation shall be SERVE FOOD SOLUTIONS, INC."

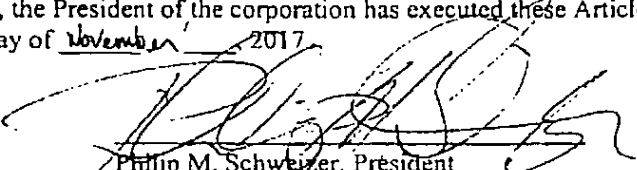
**ARTICLE III****Date of Adoption**
