ARTICLES OF INCORPORATION

OF

ARTICLE I. NAME

The name of this corporation is: X MULTIMEDIA, INC.

ARTICLE II. DURATION

The period of its duration is perpetual, beginning from the date these Articles are filed with the Department of State.

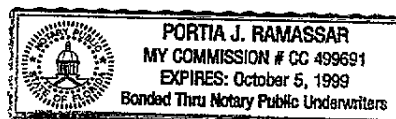

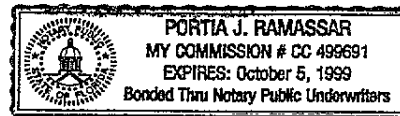
