The name of this corporation is TITO GAONA FLYING TRAPEZE ACADEMY, INC.

This corporation shall exist perpetually.

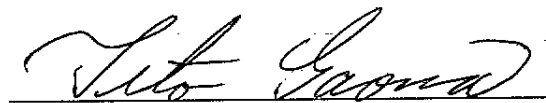
