# ARTICLES OF INCORPORATION OF SOUTHERN PRIDE SPEEDWAY, INC.

# ARTICLE I - NAME

The name of the corporation shall be SOUTHERN PRIDE SPEEDWAY, INC.

# ARTICLE II - DURATION

This Corporation shall have a perpetual duration.

# ARTICLE III - PURPOSE

This Corporation may engage in the business of constructing, creating, operating and otherwise involved in miscellaneous activities regarding a race track and in any other business as permitted under the laws of the United States of America and the State of Florida.

- 4) 13750 shares shall be held by BRUCE W. DAVIS and JEANETTE M. DAVIS in joint tenancy with rights of survivorship held by tenancy by entireties;
- 3) 13750 shares shall be held by MITCHELL B. DAVIS and LORIE J. DAVIS in joint tenancy with rights of survivorship held by tenancy by entireties;
