ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of the corporation is J M C LIMOUSINE SERVICE, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually commencing on the date of execution and acknowledgement of these Articles.

ARTICLE III - PURPOSE
