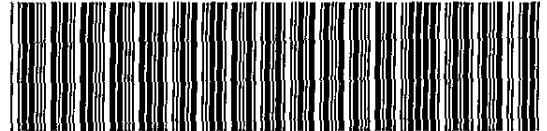

Change in the name of the Corporation:


