## ARTICLES OF INCORPORATION OF NATIVE SON FISHING CHARTERS, INC.

#### Article 1

Name. The name of this Corporation is NATIVE SON FISHING CHARTERS, INC.

#### <u>Article II</u>

Principal Office: The principal place of business and mailing address of this corporation shall be: 45 Rollins Drive, Palm Coast, Florida 32137.

#### Article III

<u>Duration</u>. The period of duration of this Corporation shall be perpetual.

#### Article IV

Purpose.
