1. The name of this corporation is:



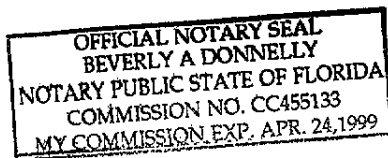
