

Pursuant to Florida Statutes Section 607.1001 and 607.1003, the Articles of Incorporation of the above-named corporation are hereby amended as follows:


1. Article I is hereby amended to read as follows:

2. This Amendment shall become effective on January 23, 2002, or on the earliest possible date after January 23, 2002.



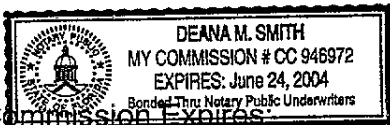
