The undersigned, for the purposes of forming a corporation for profit, pursuant to the laws of the State of Florida, do hereby adopt the following Articles of Incorporation:

ARTICLE I
NAME

The name of this corporation is **CREATIVE TRAVEL CONCEPTS, INC.**

ARTICLE II
DURATION

This corporation shall have perpetual existence commencing upon filing the Articles of Incorporation by the Department of State.

ARTICLE III
PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business, including but not limited to travel arrangements by air, automotive and marine.

ARTICLE IV
CAPITAL STOCK

This corporation is authorized to issue Five Thousand (5,000) shares of \$1.00 par value common stock, which shall be designated "Common Shares."

ARTICLE V
VOTING RIGHTS

Each share of common stock of this corporation shall entitle the holder of record thereof to one (1) vote upon each proposal presented at lawful meetings of the stockholders.

ARTICLE VI

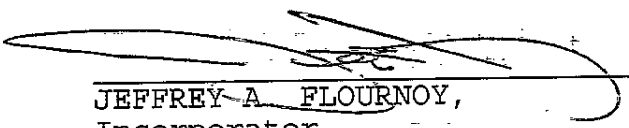
ARTICLE X
