To whom it may concern:

I am graciously requesting that you please waive the penalty fee of \$400.00 for not filing my 2000 Uniform Business Report by the deadline of May 1, 2000. My former partner, Kevin E. Maher, was responsible for this aspect of the business and filed the original report in 1998 when we started our business. In April and May of 1999, I was out of the office on maternity leave, therefore I was not aware of this report being filed or having ever been received. Only after being consulted on June 29, 2000 by my new accountant, Michael Ferraro, was I aware that such a form was to be filed annually. I just received my second notice from the Division of Corporations which I honestly state that I never received the first notice.
