ARTICLES OF INCORPORATION OF 98 JUN 11 AM 9:00 HOSPITALITY MARKETING SOLUTIONS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

- Article 1. Name. The name of the Corporation shall be HOSPITALITY MARKETING SOLUTIONS, INC.
- Article 2. Principal Office. The principal place of business shall be 310 Lighthouse Lane, Fernandina Beach, Florida 32034 and the mailing address of this Corporation shall be 310 Lighthouse Lane, Fernandina Beach, Florida 32034.
- Article 3. Shares. The number of shares of stock that this Corporation is authorized to have outstanding at any one time is 25,000 shares of common stock. Such shares shall be of a single class and shall have no par value.

- Article 6. Initial Board of Directors. The number of Directors constituting the initial Board of Directors is one. The number of Directors may be increased or decreased from time to time in accordance with the by-laws, but shall never be less than one.  - Article 7. Duration. The duration of the Corporation is perpetual.

- Article 10. Indemnification. The Corporation shall indemnify each Officer, including any former Officers, to the full extent permitted by law.

Article 11. Purpose. The general purposes for which the Corporation is organized are the following.

- A. To engage in and transact any lawful business for which corporation may be incorporated under the Florida Business Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.
