Pursuant to the Florida Business Corporation Act, the undersigned corporation adopts thes Articles of Amendment.

# FIRST:

The name of the corporation is Tradewind Equipment Leasing Corporation.

### **SECOND:**

The Articles of Incorporation of this corporation are amended by changing the Article III so that, as amended, Article III shall read as follows:

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 3,000,000 shares of common stock having no par value, unlimited voting rights and an entitlement to receive the net assets of the corporation upon dissolution.

# THIRD:

The amendment to the Articles of Incorporation of the corporation set forth above was adopted on June 30, 1998.
