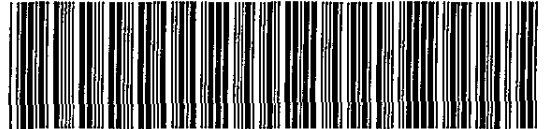

NAME TO MAURICE'S OLDE WORLD FURNISHINGS, INC.**

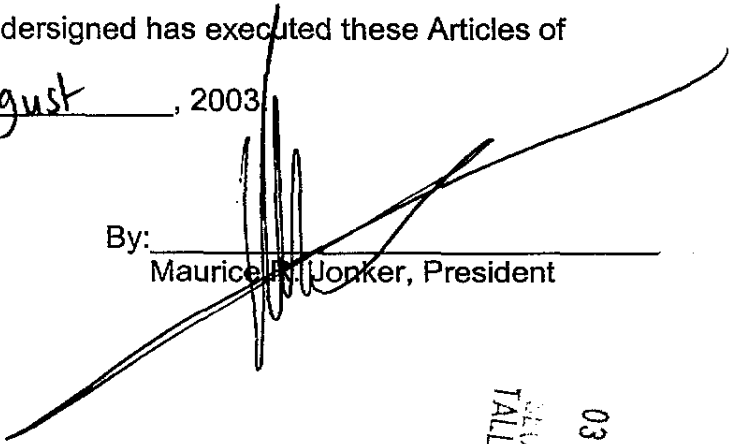
