ARTICLES OF INCORPORATION OF

C N S TRADING CORPORATION

ARTICLE I - NAME

The name of this corporation is: C N S TRADING CORPORATION, with the principal place of business located at: 10843 NW 29TH STREET, MIAMI, FL. 33172.

ARTICLE II - PURPOSE


