The Articles of Incorporation of this Corporation were filed on June 11, 1998, and assigned Document Number **P98000053273**.


**ARTICLE III.

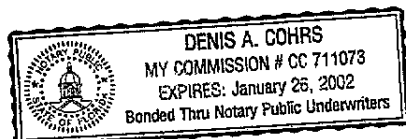



