ARTICLE I * NAME AND ADDRESS

The name of this corporation is Strong Branch, Inc. and its principle place of business shall be at 9879 Scory Ln. Stuart, Fl. 34997.

ARTICLE II * DURATION

This corporation is to exist perpetually.
