**ARTICLES OF INCORPORATION  
OF  
AZAKA DOLL INCORPORATED**

*THE UNDERSIGNED, have executed the following documents as incorporator of the above named corporation, a corporation organized under the law of the State of Florida, and all rights, duties and obligations of the undersigned incorporators, and those of the corporation, are to be determined with the laws of the State of Florida.*

**ARTICLE I**

*This corporation shall commence existence upon filing of those Articles of Incorporation by the Department of State, State of Florida, and shall have perpetual existence.*

*The general nature and purpose of the business and objects and purposes proposed to be transacted and carried on by this corporation are to do any and all the things therein mentioned, as fully and to the same extent as natural person might do. viz:*

- 1) Transact any and all lawful business
