WE, the undersigned, in order to form a corporation for profit for the purposes hereinafter stated, under and pursuant to the provisions of the Florida Statutes, do hereby subscribed to this Certificate of Incorporation, and do adopt the following Articles of Incorporation:

ARTICLES OF INCORPORATION

ARTICLE 1.

The name of this corporation shall be: CABRAL INSURANCE CORP.

ARTICLE II.

The general nature of the business and the objects and purposes to be transacted and carried on by this corporation shall be:

(a). To engage in the business of planning and sale of insurance coverage and policies including but not limited to auto. health. home. life. annuties, and any other insurance coverage whether by special agreements with specific companies and/or other agencies or with general insurance companies authorized to underwrite insurance in the State of Florida and any other activity related to the principal purpose of this corporation.

- (b) To enter into, make and perform contracts of every kind, for any lawful purpose, without limit as to amount, with any person, firm, association or corporation, town, city, country, state, territory or government.
- (c) To purchase or otherwise acquire, and to hold, own, maintain or otherwise dispose of and deal in lands and leaseholds, and any interest, estate and rights in real property, and personal or mixed property, and any franchises, rights, licenses or privileges necessary, convenient or appropriate for any of the purposes herein expressed and to have any and all powers above set forth as fully as natural persons, whether as principals, agents, trustees or otherwise.
- (d) To guarantee, purchase, hold, sell, assign, transfer, mortgage, pledge or otherwise dispose of shares of the capital stack of, or any bonds, securities ar evidences of indebtedness created by any other corporation or corporations organize under the laws of the State of Florida or any other state or government, and while the owner of such stack to exercise all the rights, powers and priviledges of ownership, including the right to vote thereon.

The maximum number of shares of stock which this Corporation shall have autstanding at any time, shall be TWO HUNDRED (200) shares, all of which shall be of \$1,00 par value and each of which shares shall be issued fully paid and non-assessable, and shall be payable in lawful money of the United States of America, or in services or property at just valuation, to be fixed by the Directors of this corporation at the organizational meeting, or any other meeting held for that purpose.

ARTICLE IV.

ARTICLE V.

This corporation is to have perpetual existence.

ARTICLE VI.
