The name of this Corporation is JETSTREAM AEROSPACE, CORP.

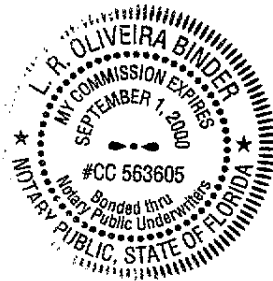
