# ARTICLES OF INCORPORATION OF INDEPENDENT COMMUNITY BANK

SECRETARY OF STATE The undersigned, acting as director (s) of the purpose of forming a corporation under and FLORIDA by virtue of the Laws of the State of Florida, adopt (s) the following Articles of Incorporation:

## ARTICLE I

The name of the corporation shall be Independent Community Bank and its initial place of business shall be at, 307 Tequesta Drive in Tequesta in the County of Palm Beach and State of Florida. EFFECTIVE DATE

ARTICLE II

The general nature of the business to be transacted by this corporation shall be: That of a general commercial banking business with all the rights, powers, and privileges granted and conferred by the Florida Financial Institutions Codes, regulating the organization, powers, and management of banking corporations.

#### ARTICLE III

The total number of shares authorized to be issued by the corporation shall be 2,000,000. Such shares shall be of a single class and shall have a par value of \$5.00 per share. The corporation shall begin business with at least \$ 2,062,500 in paid-in common capital stock to be divided into 412,500 shares. The amount of surplus with which the corporation will begin business will be not less than \$1,000,000 and the amount of undivided profits, not less than \$937,500 all of which (capital stock, surplus, and undivided profits) shall be paid in cash.

#### ARTICLE IV

The term for which said corporation shall exist shall be perpetual unless terminated pursuant to the Florida Financial Institutions Codes.
