- 1. Jorge L. Mercado is the President of TIP TOP AUTO COLLISION, INC., a Florida corporation, (herein "Corporation").
- 2. That the Corporation was administratively dissolved by the Florida Department of State on September 24, 1999.
- 3. That the Corporation failed to file its 1999 Uniform Business Report or pay the 1999 Uniform Business Report filing fee within the time prescribed by Florida Statutes Chapter 607 because:
 - 3.1 the Corporation was without knowledge that its Uniform Business Report was not filed or that the Uniform Business Report filing fee had not been paid to the Florida Department of State; and,
