1. Jorge L. Mercado is the President of TIP TOP AUTO COLLISION, INC., a Florida corporation, (herein "Corporation").

2. That the Corporation was administratively dissolved by the Florida Department of State on September 24, 1999.

3. That the Corporation failed to file its 1999 Uniform Business Report or pay the 1999 Uniform Business Report filing fee within the time prescribed by Florida Statutes Chapter 607 because:

3.1 the Corporation was without knowledge that its Uniform Business Report was not filed or that the Uniform Business Report filing fee had not been paid to the Florida Department of State; and,

3.2 the President of the Corporation was not familiar with the filing requirements for the Corporation; and,

3.3 the Bookkeeper for the Corporation stated that they would handle the filing of the Uniform Business Report and payment of the Uniform Business Report filing fee; and,

3.4 the Corporation never received notice that the Uniform Business Report and Uniform Business Report had not been received by the Florida Department of State; and,

3.5 the written notice was never received by the Corporation or its Registered Agent that the Florida Department of State was commencing a procedure to administratively dissolve the Corporation.

4. The Corporation requests the Florida Department of State to reinstate the Corporation upon the payment by the Corporation of its 1999 Uniform Business Report fees and the filing of an Application for Reinstatement, which are presented simultaneously with this Affidavit.

5. TIP TOP AUTO COLLISION, INC. satisfies the requirements of the Florida Statutes 607.0401.
6. No further ground or grounds exist for the administrative dissolution of the Corporation.
