ARTICLE I - Name

The name of this corporation is JERRY'S INDOOR ARCHERY RANGE
AND ARMY SURPLUS, INC.

ARTICLE II - Effective Date

The existence of this corporation shall begin on July 1, 1998.

ARTICLE III - Duration

This corporation shall have perpetual existence.

ARTICLE IV - Purpose
