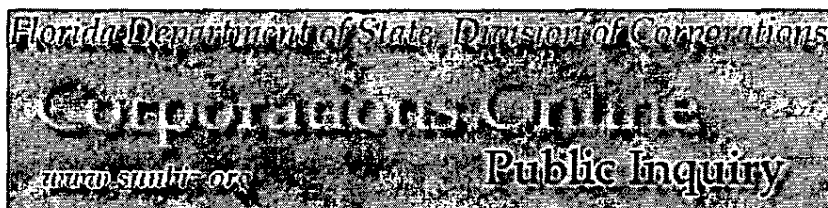

Our accountant informed us that our corporation was dissolved due to the fact of not filing the annual report on time.

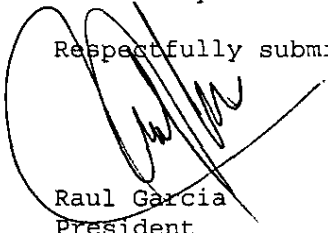
Our only excuse is that we were not aware of such filing and never received notification of such.
