ARTICLE I - NAME & ADDRESS

The name of this corporation is **COMDATA, INC.** The mailing address of the corporation is 5034 Central Avenue, St. Petersburg, Florida 33707.

ARTICLE II - PURPOSE

The purpose of this corporation shall be as follows:

- 1) The marketing and selling of communications systems and services;


ARTICLE VII - INDEMNIFICATION
