This corporation reserves the right to amend or repeal any provisions contained in these articles on incorporation.

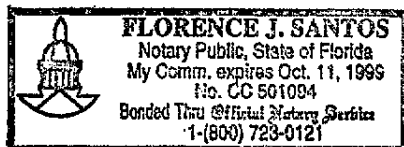
