ARTICLE I - NAME

The name of this corporation shall be Let's Go Nuts!, Inc.

ARTICLE II - DURATION

The duration of the corporation shall be perpetual.

ARTICLE III - PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business under Chapter 607, Florida Statutes, as amended from time to time.

ARTICLE IV - AUTHORIZED STOCK

The corporation is authorized to issue One Hundred (100) shares of One Dollar (\$1.00) par value common stock.

ARTICLE V - INITIAL REGISTERED AGENT

The name of the initial registered agent of the corporation is Christopher Lutsko. The street address of the initial registered office of the corporation for service of process shall be 1440 Massa Street, Kissimmee, FL 34744.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

The corporation initially shall have Two (2) director. The number of directors may be increased or decreased from time to time by the bylaws, provided that the number of directors shall not be less than one person at any time. The name and address of the initial directors of the corporation are:

ARTICLE VII - INCORPORATOR

ARTICLE XII - AMENDMENT OF ARTICLES

The corporation reserves the right to amend, alter, change, or repeal any provision or provisions contained in these Articles of Incorporation, or any amendment thereto, in accordance with the laws of the State of Florida as amended from time to time. All rights conferred upon the shareholders of the corporation are granted subject to this reservation.

ARTICLE XIII - COMMENCEMENT OF CORPORATE EXISTENCE

The date of commencement of corporate existence for the above-named corporation shall be the date of filing these Articles of Incorporation.

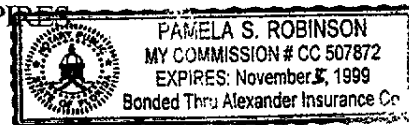
