## ARTICLE 1: NAME

## ARTICLE 4: INITIAL REGISTERED AGENT AND REGISTERED OFFICE

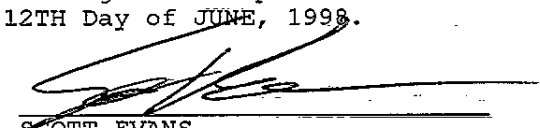
