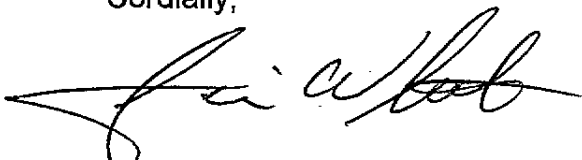

The name of this corporation is Intercoastal Enterprises Corp. *OF Broward*
