ARTICLES OF INCORPORATION

OF

A & C CHARTER SERVICES, INC.

The undersigned Incorporator, being a person competent to contract, subscribe these Articles of Incorporation to form a Corporation for profit under the laws of the State Florida.

ARTICLE I - Name

The name of this corporation shall be:

A & C CHARTER SERVICES, INC.

ARTICLE II - Business and Activities

This Corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III - Capital Stock
