

## ARTICLES OF INCORPORATION

OF

# MANAGED CARE OF BRAZIL, INC.



The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### ARTICLE I

#### NAME

The name of the corporation is Managed Care of Brazil, Inc. and its address is 999 Ponce de Leon Boulevard, Suite 940, Coral Gables, Florida 33134.

#### ARTICLE II

## DURATION

The duration of the corporation is perpetual.

### ARTICLE III

### PURPOSE

The general purposes for which the corporation is organized are:

- (1) To transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act.
- (2) To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
