ARTICLE I. NAME AND ADDRESS

The name of the corporation is: **CONSENSUS BUILDERS, INC.** The address of the corporation is 4326 El Prado Blvd., Suite 10, Tampa, Florida 33629.

ARTICLE II. DURATION OF CORPORATION

The duration of existence of this corporation is and shall be perpetual or until dissolved according to law.

ARTICLE III. PURPOSE

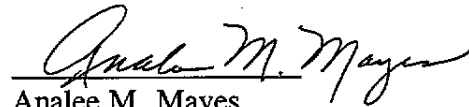

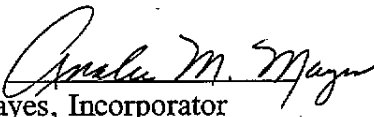

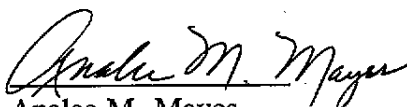
