## Dear Katherine:

We are enclosing the APPLICATION FOR REINSTATEMENT for the above-named corporation along with a check in the amount of \$150.00 in payment of the annual report fee and the corporate supplemental fee. We respectfully request abatement of the reinstatement fee of \$600 due to the following facts and circumstances:

The corporation is what is known as a "talent-loan out corporation" for a performing artist named Nikki Novak who in 1998 moved to the United States from Canada and began conducting her trade or business as an actress/model here in Florida.

Since she had not yet established an administrative office location for the Company, her boyfriend at the time assisted her by both recommending an attorney to form the corporation and allowing her to use his address as the principal office location.

Early in 1999, Nikki had an unpleasant break-up with this same boyfriend and moved elsewhere, providing the post office with a forwarding address and assuming any mail for her or the Company would be forwarded by her ex-boyfriend. What she found out later was that out of vindictiveness, her ex-boyfriend was destroying much of her mail. She was unaware of the annual report filing requirements as such was never explained to her. By the time some of the mail the ex-boyfriend did not destroy was forwarded to her in early October, it was at that time she became aware of the issue.

She is now aware of the annual report filing requirement and proper controls have now been put in place to assure a timely filing for the year 2000 and henceforth. We believe, given the above facts and circumstances, that it would not be in the interests of the State of Florida to impose a penalty in the form of the reinstatement fee.
