Today I received a Certificate of Administrative Dissolution from the Division of Corporations for my corporation referenced above. I contacted Karen Gibson, an examiner with the Division of Corporations regarding this dissolution.

I explained to Ms. Gibson that the Registered Agent and myself never received the renewal from the Division of Corporations, nor the First Notice of Renewal, nor any subsequent notice that my corporation was going to be administratively dissolved. Through no fault of mine, my corporation was administratively dissolved.

She suggested that I write the Division of Corporations, explain the unusual circumstances, complete the re-instatement form, provide the \$150.00 annual fee, and submit the entire package to the Division. She explained that the Division of Corporations would review and investigate the circumstances and the information I'm providing. Depending on the outcome of that investigation, the Division would either re-instate my corporation, request additional information and/or additional fees.

Enclosed are the following items:


