**ARTICLES OF INCORPORATION
OF
EMERALD COAST PERIODONTICS, P.A.**

ARTICLE I - NAME

The name of this corporation is EMERALD COAST PERIODONTICS, P.A....

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing on the date of filing.

ARTICLE III - PRINCIPAL OFFICE

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue One Thousand Shares of One Dollar (\$1.00) par value common stock, which shall be designated "common shares".


