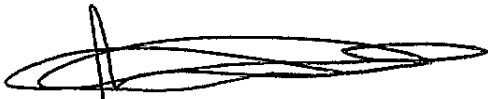

ARTICLE 1 NAME

The name of the corporation is:

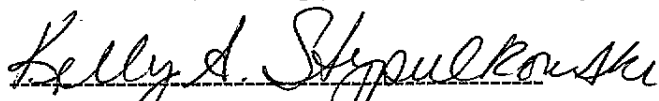
