THE UNDERSIGNED, being of legal age and desiring to form a corporation ORIDA (hereinafter referred to as the "Corporation") pursuant to the provisions of the Florida Business Corporation Act, as amended (such Act, as amended from time to time, is hereinafter referred to as the "Act"), executes the following Articles of Incorporation.

ARTICLE I

Name

The name of the corporation is COURTNEY LANDING DEVELOPMENT, INC.

ARTICLE II

Commencement of Corporate Existence
