
This is to confirm my most recent telephone conversation with your department's staff regarding Net Technologies Corp. filing of Uniform Business Report for the year 2000.

As stated previously, Net Technologies Corp. did not receive the initial report packet which should have been sent by the department. Subsequently, I called the department in late April and left a message on the department's voice mail system. In the message, I indicated that Net Technologies had not received the report forms and requested a new copy be sent. In the recording I indicated the company name, my name, mailing address, and telephone number.
