Per our conversation I am sending you this letter requesting the reinstatement of my corporation. As you have certainly noted there have been some issues that I have attempted to resolve with Tallahassee before and to-no-avail-I hope this letter will make it to your desk!

I am resubmitting the paper work with the corrections. I have made a Xerox copy of the letter so that in years coming I will not repeat the same mistakes. As also noted per our conversation there were **NO copies** for re-instatement in the letter that arrived on 5-29.

Here is the information that you have requested in letter form.

- 1. I submitted a form last year on April 30th last year, from which the check was cashed by the state, but the form found to be unsatisfactory. The form was then resubmitted twice, but still has either been found unsatisfactory, or has not been received.
- 2. I do not recall the receipt of a letter in January regarding the status of the corporation. Thinking that all this had been cleared up and was found satisfactory, this did not seem to be an issue until May 29th.
- 3. Working on the presumption that things had been cleared up previously, a UBR was filed this year in a timely fashion. This years UBR was still found to be unsatisfactory and was returned with the check stapled to it and notification that the corporation was dissolute.
