ARTICLES OF INCORPORATION OF TAFT BUILDING, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following articles of incorporation:

ARTICLE I NAME

The name of the Corporation is Taft Building, Inc.
